In this visit his wife Ms. Soheli Sultana Laboni and son Mr. Tahmid Ehsan Shabeeb will be accompanying him. All expenses in this regard will be borne personally.

e. Under no condition, leave will be extended & he must return to the country within the stipulated time limit & join to his office.

f. On return from abroad, he will submit a report to this Division within 15 days.
