Notification

The undersigned is directed to convey the Government's approval of study leave to Seikh Mohammed Shahidul Islam (ID No 2347), Deputy Director, Coordination (PSTN & Gateway), Department of Telecommunications, Dhaka on half average pay from 01 February 2023 to 31 January 2024 for attending Master of Research (MRES) at Macquarie University, Sydney, Australia under the following terms and conditions:

- a. He will draw his usual pay and allowances from Bangladesh in local currency (Half Average Pay). No part of it should be drawn in foreign currency;
- b. The expenditure relevant to this programme will be borne by him & the Government of Bangladesh will not bear any cost in local or foreign currency;
- c. On arrival in Australia he will register his name in the High Commission of Bangladesh in Australia. He will inform the Bangladesh Embassy in that country and this Division about his local address abroad;
- d. He will not be allowed to change the course or institution;
- e. He will have to submit a copy of course certificate and a report on the programme to this Division after return/completion of the programme;
- f. The provision of Appendix V and Rule 194 of BSR (Part-1) and Rule 34, Appendix VIII of BSR (Part-1) is applicable for this approval;
- g. If he resigns without working for at least 02 (two) years after completion of higher education, he will be liable to pay to the Government the amount of salary and allowance received during the course of study. Otherwise it will be recoverable from him as a government demand;
- h. He must return to the country within the stipulated time limit & join to his office;

i. Government can cancel this study leave at any time in public interest.
