- c. Airfare and hotel expenses regarding Taiwan tour will be borne by World Information Technology & Services Alliance (WITSA) and cash allowance as per entitlement will be borne by Directorate of Posts, Dhaka. All expenses regarding Singapore tour will be borne by Directorate of Posts.
- d. On return from abroad, he will submit a report to this Division within 15 days.
