- e. He will not stay abroad any longer of the approved period of deputation;
- f. He will have to join his own duty station after completion the deputation period;
- g. He will submit a report regarding the course within 15 (fifteen) days of his return from abroad.

02. The deputation period can be extended up to next three years after the successful completion of two years Masters Degree and on receiving his application.
